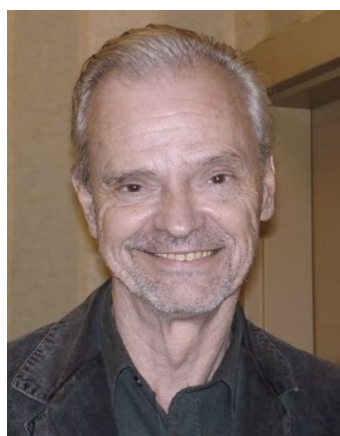

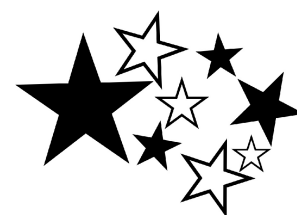

John Mohan will share lessons from many years of top-notch bridge experience, and suggest guidelines for balancing re hand strength and distribution plus vulnerability. And how much room your balancing takes away from the opponents. John is a Grand Life Master with more than 28,000 masterpoints, including more than 20 NABC and World Championships titles – two gold medals, one silver and one bronze. His most recent NABC win is the Keohane North American Swiss Teams. John was selected as the 1999 ACBL Player of the Year, and the only player to win *two* World Championship titles in the year 2000. John has three passions: bridge, tango and anti-aging nutrition. To quote John, “Bridge exercises your mind, tango exercises your body, and anti-aging nutrients help you enjoy it more.”
