"Should I Bid?... or Not"



Valentin Ivan Kovachev is a bridge professional who spends his time traveling between the United States and Bulgaria, currently residing in Las Vegas.

Val started playing bridge in college at 22, which is considered a late start in Bulgaria. From 2003-2007, Val ran the largest bridge club in Bulgaria, and during that time became a many time champion: National Bulgarian Champion in teams, Mixed Pairs, Open Pairs and individual events. Val began playing professionally in 2003 and

has won 19,000 masterpoints and a national championship here. He will give us expert tips on when to bid and when to pass – the secrets of competitive bridge.

Val currently coaches and trains the Bulgarian Women's and Open Teams. He has also worked with the national teams of Turkey, the Netherlands and England.
